CONSEQUENTLY THE MODEL CODE OF CONDUCT HAS COME INTO FORCE IN ALL THE TWELEVE DISTRICTS EXCEPT OF URBAN LOCAL BODIES AND WILL REMAIN EFFECTIVE TILL THE ELECTION PROCESS IS COMPLETE (.) HENCE NO STATE GUEST FACILITY REPEAT NO STATE GUEST FACILITY WOULD BE EXTENDED TO ANY CENTRAL/STATE MINISTER AND THE ACCOMPANYING STAFF EXCEPT IN CASE OF FAILURE OF LAW AND ORDER OR CALAMITY OR ANY SUCH EMERGENCY WHICH REQUIRES PERSONAL PRESENCE OF CHIEF MINISTER, MINISTERS FOR SPECIFIC PURPOSES (.)

THE MODEL CODE OF CONDUCT WILL BE EQUALLY APPLICABLE TO THE NON-OFFICIAL CHAIRMEN/MEMBERS OF STATUTORY BODIES AND THEIR ACCOMPANYING STAFF CONSTITUTED BY THE STATE GOVERNMENT (.) GOVT. MACHINERY, OFFICIAL AMENETIES INCLUDING OFFICIAL CARS/VEHICLES, GUEST HOUSES' FACILITY, ETC, OR OFFICIAL HOSPITALITY ARE ALSO NOT TO BE AVAILED BY THE AFORSAID PERSONS DURING THE PERIOD OF THESE ELECTIONS (.) ANNOUNCEMENT OF ANY FINANCIAL GRANT IN ANY FORM OR SANCTION OF PROJECTS OR SCHEMES OF ANY KIND OR PROMISE THEREOF, LAYING FOUNDATION STONES, OR INAUGURATION OF ANY PROJECT, OFFICIAL BUILDING, ROAD, ETC, OR ANY SCHEME RELATED TO THE RURAL AREA OR MAKING ANY ADHOC APPOINTMENT IN GOVT., PUBLIC UNDERTAKING ARE ALSO NOT TO BE MADE BY THEM TILL THE COMPLETION OF THREE TIER PANCHAYAT GENERAL ELECTIONS (.) KINDLY ENSURE ACTION ACCORDINGLY (.)
